1. POSITION OFFERED

1.1. A job is being opened to cover 1 **Position of Senior Platform Technician (G3-Research Support Staff)** to support **FUNDACIÓ CLÍNIC PER A LA RECERCA BIOMÈDICA (FCRB)** to be part of the "Recovery and Resilience Mechanism Investigo Program", with Grant Agreement number 2PLAZO-POSICION-09 funded by the European Union, Next Generation EU with a temporary contract and at the Biobank Platform in the following category professional:

Required qualifications and skills:

- ✓ **Required Degree:** Bachelor or similar/equivalent (minimum 300 ECTS credits) in Bioinformatics, Biomedical Sciences or similar.
- ✓ **Specialty/Master:** Master's degree in Data Management or similar will be valued.
- ✓ **Required Experience:**
 - Desired previous experience:
 - Experience managing big databases and in metadata analysis.
 - Knowledge of programming languages (Phyton, Perl, etc.).
 - Record of working within a hospital environment or having managed clinical data will be and added asset.
 - Experience in informatics systems (such as SAP or similar).
- ✓ **Other skills:**
 - We look for a team player, responsible and proactive, creative and with a problem-solving attitude.
- ✓ **Languages:** English (Catalan and Spanish will be a plus).
- ✓ **Be between 16 and 30 years old.**
- ✓ **Be unemployed and registered in the SOC as a person seeking employment.**
- ✓ **Not having been linked to the Institution through a contractual relationship in the previous 6 months before starting the contract.**
- ✓ **It is essential to send the application using a blind curriculum vitae which we specify below what data it must indicate.**

Job description / Tasks to be developed:

The candidate will take the role as a technician for the data management inside the HCB-IDIBAPS Biobank. The candidate will be managed by the Biobank Coordination team. The candidate will manage data of crucial interest for biomedical research such as data from patient characterization, derived samples and the Biobank's sample catalogue. Specifically, tasks will be:

- ✓ To curate Biobank's sample databases, set up of a minimum basic data collection and follow-up of these processes when implemented by the Biobank's collaborators.
- ✓ Bioinformatics optimization and automation for uploading sample-related data for samples processed within the Biobank or collaborative centers. The aim is to improve the offer and quality of samples and data for the Scientific Community of the Health National System.
- ✓ To search for new clinical and analytical data within the hospital informatics system (SAP). To compile (pre)analytical data, integrate the dataset into the Biobank LIMS system (NorayBanks) and review and maintain its register.
- ✓ To interact with researchers and collaborators from the Biobank to improve adaptation of the databases to standards and requirements of translational projects (through clinical, pathological and data management criteria).
- ✓ To elaborate activity reports and analyze the Biobank's data collection workflow.
- ✓ To engage in communication activities regarding the sample and data catalogue from the Biobank and its activity.

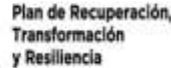
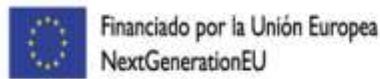

In the CV you must NOT indicate any of the following personal data that are detailed. If they are indicated in the application, it will be invalidated, and these data are as follows:
